HeinOnline ist eine umfangreiche Sammlung juristischer Materialien der Vereinigten Staaten von Amerika, Großbritanniens und des Commonwealth. Die HeinOnline Plattform enthält dabei (je nach Lizenzierung) u.a. über 1000 relevante anglo-amerikanische Rechtszeitschriften ab Erscheinungsbeginn, US-amerikanische Verträge und Abkommen, und U.S. Supreme Court Entscheidungen.

Die Plattform ist dabei in verschiedene (lizenzierte) Bibliotheken (Collections) unterteilt. Diese Collections werden links auf der Startseite von HeinOnline gelistet und durch einen Klick auf die einzelnen Collections gelangt man zu den Inhalten der jeweiligen Bibliothek.



HeinOnline bietet auf der Startseite einen Direktzugang zu den Inhalten der einzelnen Collections, über einen Volltext Suchschlitz.



Über den Tab „Advanced Search“ ist zudem eine erweiterte Suche möglich.



Neben der Volltextsuche erlaubt HeinOnline zudem die Möglichkeit eine Katalogsuche („Catalog Search“) bzw. eine Suche nach einer spezifischen Zitation („Citation Navigator“ bzw. für Entscheide „Fastcase“) durchzuführen. Eine solche Suche setzt hingegen selbstverständlich voraus, dass man den Titel eines Werkes bzw. den entsprechenden Zitierhinweis der Zeitschrift oder des Entscheides kennt.




